The package includes many essential items for a new start in one's own home, such as dishes, pots and pans, a toaster, a coffeepot, casserole dishes and some cleaning supplies. The package provides the basics Veterans will need when they move out on their own.

The VAF developed the requirements for the Graduation Package over the last two years. We started with a curriculum entitled "Rent Smart", a series of 11 classes covering topics necessary for a successful tenant experience. Following that, requirements for budget counseling and good discharge planning were also necessary prior to receiving the Graduation Package.

Coinciding with the required courses, the resident must also have been compliant with the program, meeting our program requirements and their own goals in every area, without experiencing a substance abuse relapse.

Herbert G. completed all the requirements for the package before he successfully discharged from the 407 program and transitioned into his own apartment.
