SUPERMARKET AT THE MILWAUKEE COUNTY ZOO

The Veterans Assistance Foundation was fortunate to participate in the Supermarket at the Milwaukee County Zoo held over the July 4th weekend. While we were able to make connections with veterans that were in need of our services, it was also an opportunity to guide others to the services that they were in need of. (MADISON) – About 9,000 people attended a military and veterans family day at the Milwaukee County Zoo, which also included a Supermarket of Veterans Benefits, hosted by the Wisconsin Department of Veterans Affairs (WDVA).

Veterans were able to learn about an array of state and federal benefits at one convenient location – in the U.S. Bank Gathering Place. There were around 40 service providers on hand, including the U.S. Department of Veterans Affairs, County Veterans Service Offices, veterans service organizations, education centers and community organizations. Attendees had the chance to talk with them about VA health care, education benefits, veterans homes, loans, military funeral honors, women veterans programs, medals and honors and more.

Dave Saula, a Vietnam veteran from Milwaukee, stopped in at the Supermarket. "I came here last year, and to the one at the state fair, to see old friends and talk," said Saula. "There's a connection between all branches of service."

Many newcomers also visited the Supermarket. Milwaukee County Veterans Service Officer (CVSO) Jim Duff said he talked with many veterans. "It's nice to see fresh faces," Duff said. "There are people coming here for the Zoo, and they realize there's information here about their benefits. That's what we're here for I'm seeing a lot of new people."

Brian Walker was one of the new service providers working at the Supermarket this year. Walker, who worked for the federal VA for 25 years, recently began working in the Public Affairs Office of the Zablocki VA Medical Center in Milwaukee. He mentioned, "I talked with three veterans who didn't think they were eligible for health care benefits, and it turns out they are."

Kelly Rotruck visited the federal VA booth, among others. She is a U.S. Army veteran who served from 1983-1989 and lives in Butler. "I came here to talk to the VA Regional Office and check on my education benefits," Rotruck said. "All I have to do is go to the CVSO office and sign up, and I hope to go back to school in the spring." Rotruck also said she signed up with the WDVA Women Veterans Coordinator for the Wisconsin Women Veterans News online.

Another veteran interested in education benefits, as well as others he is eligible for, was Operation Iraqi Freedom veteran Herbert Raasch of Milwaukee. Raash found out about the Supermarket "through my vet advisor at school – she gave me a flyer." Raash said, "I already knew about education benefits. I came to find out if I am maxing out all my benefits. I'm in school now on the Post 9/11 and Wisconsin GI Bills. I found out my kids are also eligible for education benefits."

TRAINING EXERCISES FOR VAF EMPLOYEES

Ensuring the safety and well being of the VAF residents and staff is paramount and the number one priority within the Veteran Assis-

tance Foundation. This was evident when the VAF reached out to the Tomah Veterans Affairs Medical Center Fire Department for assistance in providing training on these important procedures.

On June 1, the VA Fire Department put on a training exercise for the new VAF Staff and Security Officers who had not yet completed this training. The first exercise was learning how to correctly operate a fire extinguisher while putting out a fire. There are four steps when putting out a fire with a handheld fire extinguisher. These steps correctly followed, will successfully put out a small fire. They are:

Pull
Aim
Squeeze
Sweep

The VA Fire Department also taught staff how to correctly and safely transport a person unable to evacuate themselves down a stairway during a fire. In each of the stairways of our building there are Evacuation Chairs, one for each floor. The person needing assistance is securely strapped into the chair and two

The following is written by Jerry C.:

After a long battle with my addiction, I got sick and tired of living the way I was living. I was always praying that this would end. After living in Dallas, Texas for almost 10 years, I moved back to Rockford, Illinois with almost two years clean and started looking for work. There were no jobs anywhere, so I had went online and saw the Veterans Assistance Foundation (VAF) program for homeless vets and where you can possibly get to truck driving school and they would pay for it (through the HVRP grant). My plans were to come up here and go to school for truck driving.

After arriving and being here for a little while, my sponsor thought it would be better for me to work on my recovery. After working in the IT and CWT programs at the VA, I eventually got a job at Ft. McCoy, working for Challenge Unlimited. After being there for a year, I was promoted to Supervisor and was given my own crew to run. I attend church in Tomah and I also go to NA and AA meetings in Tomah. I continue to work on my sobriety with the help of a support network and the staff at the VAF.

In the meetings that I had with Janet, the VAF AODA Technician, we also discussed communication skills, I statements, talking to others, relapse, prevention, body language and negotiation skills. We also worked on skills about getting along with others (seeing others' viewpoints), goal setting and planning and more. Janet helped me to keep things in a positive perspective. She kept me motivated to continue to grow and change.
